



Maryland Sustainable Growth Awards 2015

Presented by the Maryland Sustainable Growth Commission

About the Award

The Maryland Sustainable Growth Award, presented annually by the Maryland Sustainable Growth Commission, is the highest level of recognition for smart growth and sustainability in the state.

The award honors and celebrates significant achievements by individuals, businesses, organizations and local governments in their efforts to realize the Twelve Visions adopted by the Maryland General Assembly.

1. Quality of Life and Sustainability: A high quality of life is achieved through universal stewardship of the land, water, and air resulting in sustainable communities and protection of the environment.

2. Public Participation: Citizens are active partners in the planning and implementation of community initiatives and are sensitive to their responsibilities in achieving community goals.

3. Growth Areas: Growth is concentrated in existing population and business centers, growth areas adjacent to these centers, or strategically selected new centers.

4. Community Design: Compact, mixed-use, walkable design consistent with existing community character and located near available or planned transit options is encouraged to ensure efficient use of land and transportation resources and preservation and enhancement of natural systems, open spaces, recreational areas, and historical, cultural, and archeological resources.

5. Infrastructure: Growth areas have the water resources and infrastructure to accommodate population and business expansion in an orderly, efficient, and environmentally sustainable manner.

6. Transportation: A well-maintained, multimodal transportation system facilitates the safe, convenient, affordable, and efficient movement of people, goods, and services within and between population and business centers;

7. Housing: A range of housing densities, types, and sizes provides residential options for citizens of all ages and incomes.

8. Economic Development: Economic development and natural resource-based businesses that promote employment opportunities for all income levels within the capacity of the State's natural resources, public services, and public facilities are encouraged.

9. Environmental Protection: Land and water resources, including the Chesapeake and coastal bays, are carefully managed to restore and maintain healthy air and water, natural systems, and living resources;

10. Resource Conservation: Waterways, forests, agricultural areas, open space, natural systems, and scenic areas are conserved.

11. Stewardship: Government, business entities, and residents are responsible for the creation of sustainable communities by collaborating to balance efficient growth with resource protection.

12. Implementation: Strategies, policies, programs, and funding for growth and development, resource conservation, infrastructure, and transportation are integrated across the local, regional, state, and interstate levels to achieve these Visions.

About the Sustainable Growth Commission

The Maryland Sustainable Growth Commission is charged to

- Assess and advise on the progress of State, regional, and local planning in Maryland in achieving the goals of the State economic growth, resource protection, and planning policy, as defined in § 5 7a-01 of this title;
- Make recommendations on the adequacy, coordination, and implementation of funding mechanisms and other State assistance for planning activities and infrastructure and land preservation needs, consistent with the State economic growth, resource protection, and planning policy;
- Promote planning coordination and interjurisdictional cooperation among the State and local jurisdictions and recommend mechanisms to facilitate voluntary joint planning;
- Advise on the content and preparation of the State development plan, State transportation plan, and State housing plan and the implementation of these plans, including the relationship of these plans with local land use plans;
- Promote and make recommendations regarding efficient and predictable model State and local development regulations to achieve the goals of the State economic growth, resource protection, and planning policy;
- Evaluate the continuing viability and effectiveness of the State and local government smart growth indicators contained in Article 66B, § 3.10 of the Code, and make recommendations for amendments or additions to the indicators;
- Review the reports of local jurisdictions on adequate public facilities development restrictions required by Article 66B, § 10.01 of the Code, and assess whether and to what extent adequate public facilities ordinances affect the achievement of the goals of the State economic growth, resource protection, and planning policy;
- Develop and assist in the implementation of educational and outreach programs about smart growth;
- Review periodically the educational requirements for members of planning boards and Commissions and boards of appeals required by Article 66B, §§ 3.02 and 4.07 of the Code, and evaluate compliance rates for the members;
- Make recommendations for changes in State law, regulations, policies, and procedures, if any, that the Commission believes are necessary to achieve the State's economic growth, resource protection, and planning policy; and
- Serve as an advisory board to the Governor's Smart Growth Subcabinet, providing advice and guidance.



Award Types

Leadership and Service

Recognize individuals, organizations, agencies and institutions for laudable activities or accomplishments that advance the public's appreciation, understanding and/or involvement in promoting smart growth and sustainable communities at the local, regional, or state levels. The activity or service can be related to a specific project or advocacy effort or recognize leadership or involvement with activities or organizations over time. Examples of nominees might include elected officials, local government staff/nonprofit organization staff, members of the business community, etc. Nominations will be evaluated on the extent to which an individual and/or organization's contributions have significantly advanced the public's appreciation, understanding and/or involvement in smart and sustainable growth or preservation and resource protection in Maryland. The activity or service must have been completed within the last two years or be ongoing.



Smart Growth Communities

Recognize outstanding achievements by individuals, organizations, government agencies and other entities for projects and activities of all sizes and scopes and on all types of properties. The project/activity submitted embodies, results in, or encourages development that addresses at least one of the Twelve Visions.



Successful nominations will likely address several of the smart growth principles rather than just one. The Commission will evaluate nominations for (1) public projects and programs and (2) private developments.

Nominations will be evaluated on the extent to which a project is:

- **Effective.** What are the goals of the project, and is there tangible evidence of success?
- **Collaborative.** What public outreach and community involvement has occurred, and how did it influence the project?
- **Innovative.** Does the project or activity take a new approach or present new ideas for others to apply elsewhere?
- **Responsive to environmental and community impact.** Does the project or activity improve the environment or the quality of life in the community?

All nominated projects must have been completed within the last two years.

Preservation / Conservation Projects

Preservation/Conservation Project awards are presented to individuals, organizations, government agencies and other entities for their accomplishments in protecting or improving farms, forests, natural resources and the waters of Maryland. This award recognizes outstanding efforts to:

- save Maryland's farm and forest land, promoting environmentally sound farming practices and supporting a sustainable future for farms;
- promote habitat management and wildlife conservation; and
- protect the environment and advance conservation practices.



Nominations will be evaluated on the extent to which the project:

- directly or indirectly benefits agricultural preservation, wildlife, natural resource conservation or environmental protection;
- collaboratively involves public and private organizations; and
- serves as an example/inspiration to others.

All nominated projects must have been completed within the last two years.

How to Submit a Nomination

Eligibility

- Individuals, nonprofit and for-profit organizations or institutions, and federal, state and local agencies are all eligible.
- Current MDP staff, Maryland Sustainable Growth Commission members, and projects solely sponsored by MDP are not eligible.
- Self-nominations are accepted.

Review and Selection Process

The Maryland Sustainable Growth Awards are presented by the Maryland Sustainable Growth Commission. All nomination materials are reviewed for completeness by Maryland Planning Department staff prior to review by a committee of the Commission. That committee recommends award recipients to the full Commission for consideration and final approval. When preparing your nomination it may be useful to consider the following:

- Nominations are reviewed and selected on a competitive basis and the Commission may elect not to present an award in a given category if the nominations do not meet the criteria.
- The Commission reserves the right to evaluate nominations for categories other than those proposed by the nominator.
- Concise, accurate and complete proposals that clearly state the worthiness of the nominee will be the most competitive.
- Nominators may submit no more than two nominations per category.

- The awards will be presented at the Miller Senate Office Building, Annapolis, in January 2015.

NOMINATION DEADLINE September 19, 2014

General Information

- Materials should be organized to facilitate review by the selection committee.
- Nominations must include the nomination form and supporting images in a digital format.
- All nomination materials will become the property of the Maryland Department of Planning. MDP may use materials in the awards presentation, for publicity or other purposes.

Use the checklist below to check your nomination for completeness. Nomination packages missing any items may be considered incomplete and will not be reviewed.

Nomination Form

Submit completed nomination form electronically to chuck.boyd@maryland.gov and arabia.davis@maryland.gov by no later than 5 p.m. Friday, September 19, 2014.

Photographs

- To submit photographs, upload to a web-based file sharing service of your choice (i.e. DropBox, Google Drive, OneDrive) and send share invitation to arabia.davis@maryland.gov. Or contact Arabia Davis to request an invitation to our shared storage.
- Images are used to review nominations and to illustrate award-winning projects during a public award presentation ceremony. Except for the Leadership & Service Award, no fewer than 10 images of the property, activity and other appropriate subjects that document the nomination should be submitted. A minimum of one photo of a person or group nominated for the Leadership and Service Award is required. Please select images that help illustrate the project and that will further the public's understanding of the project.
- All photos should be submitted in .jpg file format.
- Save images individually and label each photograph. Photo montages, PowerPoint slides, formatted presentations, or images imbedded in documents will not be accepted. Label each with a descriptive file name or attach a photo key to the nomination form that describes each image.
- Prints and slides are not necessary

Supporting Materials

- Include any supporting materials necessary to understand the nominated projects. You may submit brochures, pamphlets, and DVDs as appropriate to help MDP understand and appreciate the project. These materials are preferred electronically as attachments or web links.
- All supporting materials will become property of MDP and will not be returned.
