



Maryland Department of Transportation (MDOT) Mission

The Maryland Department of Transportation is a customer-driven leader that delivers safe, sustainable, intelligent, and exceptional transportation solutions in order to connect our customers to life's opportunities.







The Maryland Transportation Plan (MTP) and Maryland Bicycle and Pedestrian Master Plan

What is the MTP?

- A 20-year vision for transportation in Maryland that outlines the State's transportation policies and priorities and helps guide Statewide investment decisions for all methods of transportation.
- The MTP is submitted annually to the Maryland General Assembly as part of the State Report on Transportation, along with the Consolidated Transportation Program (CTP) and Attainment Report on Transportation Performance.
- The FAST Act now requires that states' long-range statewide transportation plans use performance-based approaches that support national goals.

What is the Bicycle and Pedestrian Master Plan?

 The Bicycle and Pedestrian Master Plan establishes a 20-year vision to support cycling and walking as modes of transportation in Maryland. The Plan provides guidance and investment strategies to support cycling and walking, both on-road and off-road, as part of Maryland's multimodal transportation network.







2040 MTP - An Overview

- Last updated in 2014
- Updated every 4-5 years to address current and future transportation challenges
- Establishes a 20-year vision for transportation in the State and provides policy direction through statewide multimodal goals and objectives
- Includes a summary of the types of programs and strategies to achieve goals and objectives
- Aligns goals and strategies with performance measures
- Is updated through consultation and outreach to all Transportation Business Units, state, regional and local governments, and the general public







Maryland Bicycle and Pedestrian Master Plan 2019 Update

- Last updated in 2014
- Updated every 4-5 years, in close coordination with the MTP
- Establishes a 20-year vision to support cycling and walking as modes of transportation in Maryland
- Provides guidance and investment strategies to support cycling and walking, both on-road and off-road, as part of Maryland's multimodal transportation network.





2040 MTP - Schedule

Purpose: to update Maryland's long-range transportation plan to meet federal and state requirements, to be finalized by January 2019, as required by law.

- Winter 2018 Region-level Investment and Implementation Strategies
- Winter 2018 Develop Performance Measures
- Spring/Summer 2018 Draft Plan
- Summer/Fall 2018 Outreach on Draft Final Plan & Proposed Performance Measures
- Fall 2018 Finalize MTP and Attainment Report







2019 Bicycle and Pedestrian Master Plan Schedule

- Fall 2018 -Prepare and Release Draft Plan
- January 2019 Release of Final Plan




