¹ Geolocated parcels are unlocated parcels that were geolocated to the State's Public Safety Address Points (PSAP) dataset on street address (PTYPE 60 parcels) and, for Baltimore County only, parcels where the location was improved using the parcel premise address and/or account number with other source data including local parcel maps and U.S. Census Bureau TIGER/Line files (PTYPE 39 parcels). Note that geolocated points (points with a PTYPE value of 60) may not be placed as accurately as PTYPE 2, 20, 21 and 51 points which have been placed by deed and/or plat.

² Edition year indicates the most current year built (YEARBLT) for which a complete and comprehensive set of parcels for every jurisdiction can be assembled statewide.

³ Sales included in the Sale Database are typically for the 12-month period immediately preceding the month of the Sales Database; for example, a January 2018 Sale Database typically includes sales from January 1, 2017 through and including December 31, 2017.
