Summary

In accordance with the provisions of Chapter 541 (House Bill 759) of the Acts of the General Assembly 2002, the Maryland Department of Planning (Planning) is pleased to transmit the FY 2024 Year End Report of the Maryland Historic Revitalization Tax Credit Program. The Tax Credit Program is a program of the Maryland Historical Trust (MHT). MHT is the official State Historic Preservation Office for Maryland. The Director of MHT also serves as the State Historic Preservation Officer for purposes of the National Historic Preservation Act. MHT works to identify, evaluate, interpret, protect, and enhance heritage resources throughout Maryland since its creation in 1961. This report is submitted in accordance with the requirements of §5-A-303(h) of the State Finance and Procurement Article, Annotated Code of Maryland.

The Maryland Historic Revitalization Tax Credit Program

The Maryland Historic Revitalization Tax Credit plays a key role in revitalizing Maryland's communities by supporting the rehabilitation and reuse of historic properties across the state. The program (previously known as the Maryland Heritage Structure Rehabilitation Tax Credit), which includes Competitive Commercial, Small Commercial and residential Homeowner tax credits, has helped restore more than 5659 homeowner and 872 commercial historic structures since it was established in 1997. The availability of the 20% (25% for federal low-income housing tax credit or high-performance commercial buildings and 5% or 7.5% for opportunity zones) has been an essential tool in preserving buildings that contribute to the distinct character and economic vibrancy of Maryland's towns, cities, and rural areas.

In FY24, a total of \$5,706,151.06 in credits were issued to successfully completed projects across the state, representing more than \$28 million of capital investment in the redevelopment of historic properties and communities across Maryland. Of these, 4 projects participated through the Competitive Commercial program, 13 through the Small Commercial program and 103 through the Homeowner program.
