The Detailed DHC-B contains Household Type and Tenure information, including the total count of households, for 300 detailed race and ethnicity groups and 1,187 American Indian and Alaska Native tribes and villages. These are the same detailed groups that were published in the 2020 Census Detailed Demographic and Housing Characteristics File A (Detailed DHC-A) in September 2023. To protect respondent confidentiality, data have undergone disclosure avoidance methods which add "statistical noise" - small, random additions or subtractions - to the data so that no one can reliably link the published data to a specific person or household. As a result, data users may observe implausible and improbable data within this data product and compared with other 2020 Census data products. For example, the number of households reported for the Household Type data and the Tenure data will likely not match for a given geography and group – as the statistical noise was infused separately.
